## **CCTV Cameras on Trees**

We have been contacted recently by Birmingham City Council's Tree Officer with regard to CCTV/security cameras being mounted on trees. This practice can be injurious to the tree's health and can be hazardous if unplanned or urgent works to the tree are required (this is common after stormy weather). For the cameras to be operative electrical cabling is usually attached to the tree and this makes it unacceptably dangerous for tree surgeons to carry out emergency works. We are informed that as two cameras of this nature have recently been spotted by the Tree Officer checks will be carried out and fines may be issued.

## Road Sweeping

Over the last few years Estate roads have been mechanically swept on a quarterly basis. We have been able to work with our grounds maintenance contractors, Edges & Hedges, to find a more economical way of carrying out these sweeps and from now on they will be carried out more frequently. With immediate effect these sweeps will be on a bi-monthly basis and additionally after stormy weather.

## The Fordrough Footpath

As most residents will know, the Fordrough footpath (the footpath that leads from Hartopp Road to the park – adjacent to The Moorlands) has been closed on safety grounds and will be re-opened as soon as possible. We apologise for any inconvenience and will ensure that residents are kept advised by e.mail.

## **The Moorlands**

The fence that runs alongside the footpath and the pavement in The Moorlands suffered serious storm damage recently and will be replaced shortly.

## **Sunday Working**

There is a restriction in deeds of covenant restricting external building works to 8am – 6pm on weekdays and 8am – 1pm on Saturdays. This means that works of this nature, which cause inconvenience and nuisance to neighbours, are not permitted on Saturday afternoons, Sundays or bank holidays. This is re-enforced in the enclosed Residents Guide Book. There have been cases recently of works being carried out on Sundays, including the parking of multiple contractors' vans, causing nuisance to residents. Please respect this restriction.
